## SUMMARY ANNUAL REPORT FOR THE IRON WORKERS PENSION PLAN OF WESTERN PENNSYLVANIA

This is a summary of the annual report for the Iron Workers Pension Plan of Western Pennsylvania, Employer Identification Number 25-1283169, for the period January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

# BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a Trust. Plan expenses were \$22,449,107. These expenses included \$747,569 in administrative expenses, \$1,092,662 in investment management fees, and \$20,608,876 in benefits paid to participants and beneficiaries. A total of 2,871 persons were participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these persons had yet earned the right to receive benefits.

The net assets of the Plan, after subtracting liabilities, was \$280,723,825, as of December 31, 2023, compared to \$264,440,275 as of January 1, 2023. During this period, the Plan experienced an increase in its net assets of \$16,283,550. This increase included unrealized appreciation or depreciation in the value of the Plan's assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

Including employer contributions of \$17,493,720, earnings from investments of \$20,195,567, and unrealized appreciation of assets of \$1,043,370, the Plan had a net income of \$38,732,657.

#### MINIMUM FUNDING STANDARDS

An Actuary's statement shows that enough money was contributed to the Plan to keep it funded in accordance with the minimum funding standards of ERISA.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- 5) Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.
